## ★ Issue Spotlight ★

### Civil Liability Protections

Providing liability protections to businesses against frivolous lawsuits related to the pandemic was the key policy issue for the Chamber this session. Senate Bill 1377, which protects businesses and organizations from undue litigation as a result of the pandemic, passed with broad support from the business community and other interested parties. This bill will protect businesses who have taken appropriate action to protect their employees, customers, and tenants from frivolous civil lawsuits that could cost them their livelihoods. Many businesses underwent significant costs to implement enhanced safety measures during the pandemic to keep their employees and customers safe. These businesses who prioritized safety should not be subject to frivolous lawsuits after acting responsibly.

SB 1377 is good for business and it's good for Arizona. It will retroactively protect the thousands of businesses and other organizations here in Arizona who did the right thing and acted in good faith to remain operational while complying with health guidelines to keep customers and employees safe. This bill will cover a gamut of businesses and organizations, ranging from health care providers to business and entertainment providers, schools and districts, nonprofits, religious organizations, and more. However, this legislation rightfully allows for repercussions against bad actors, who are not taking the necessary precautions to keep people safe and healthy.
