

LEGISLATIVE SESSION HIGHLIGHTS

2022 marked the 55th Legislature – Second Regular Session, and the Greater Phoenix Chamber's public policy team was hard at work advocating for Arizona businesses. This year's key successes include striking down numerous mandate bills, which would have impeded business' ability to set appropriate workforce policies for their business models and employees. Additionally, the Chamber was instrumental in passing legislation to keep Arizona competitive on business, personal, and property taxes.

PRO-BUSINESS PROPERTY TAX MEASURES CROSS THE FINISH LINE

The Chamber strongly supported the passage of two bills crucial to Arizona's competitiveness on taxes. HB 2822 prospectively sets the valuation factor for specific personal property at 2.5%. This uniform rate ensures certainty and simplicity for businesses moving forward. SB 1093 continues last year's momentum reducing the business property tax valuation assessment. After full implementation, the assessment for businesses will fall from last year's 18% rate down to 15% in 2027. This is a significant measure for businesses that will allow more investment into capital projects or other areas of their business operations.



GOVERNMENT MANDATES: BAD FOR BUSINESS!

A cadre of bills were introduced this session that would have inserted the heavy hand of government into private business operations. These bills put the business community at risk for increased liability and heavy fines for implementing policies that best met the needs of their individual workplaces, specifically as it related to COVID-19 and firearms policies.

While the Chamber consistently advocated for businesses to follow recommended health and safety protocols, and provided businesses with resources to do so, it was imperative this legislation be stopped to ensure the employer autonomy that makes Arizona a top destination to do business.

PROP 400 EXTENSION

Transportation infrastructure remains a top priority for business development throughout the region. The Greater Phoenix Chamber was a leading organization in efforts to pass the Prop 400 extension, which would have continued the half-cent sales tax to support critical infrastructure for the next 25 years. Unfortunately, the issue did not make it across the finish line this year, however the Chamber will continue efforts to educate elected officials and voters on the benefits of extending Prop 400. The extension would have funded freeways, roads, and transit to ensure infrastructure keeps up with Arizona's rapid growth and moves our economy forward.

WORKFORCE

Companies base expansion and relocation decisions on the availability of talent in a city or region. Without robust talent pipelines, the Greater Phoenix region risks losing companies and high-wage jobs. Serving as a catalyst for partnership, the Foundation convenes six employer-led workforce collaboratives to address the growing skills gap facing our community. Each collaborative focuses on engaging key stakeholders to champion holistic and scalable workforce solutions for the Greater Phoenix region.

















ADVANCED MANUFACTURING

The Advanced Manufacturing Workforce Collaborative—which includes small and large organizations— is focused on strengthening the region's advanced manufacturing education and training systems and increasing industry and career awareness among youth and adults. In partnership with AccelerateED and the Bill and Melinda Gates Foundation, the Foundation has formed a design team to develop and scale high school manufacturing CTE pathways that lead to an associate degree one year after graduation.



The Construction Workforce Collaborative including commercial and residential contractors and subcontractors— is focused on attracting opportunity youth, women, veterans, and other individuals to launch highpotential careers and pursue opportunities to earn while they learn through the Build Your Future Arizona (BYF) campaign.

CYBERSECURITY & INFORMATION TECHNOLOGY

Arizona is an emerging tech market with thousands of technology companies. The Cybersecurity and IT Workforce Collaboratives aim to strengthen the tech talent pipeline to ensure Arizona will meet the fast-growing demand for IT and cybersecurity related occupations. The Collaboratives include a diverse group of employers, industry professionals, educators, and training partners with the shared mission to sustain the growth across the state.

- Tripled virtual cybersecurity and technology externships
- Partnered with 18 employers and 22 guest speakers to serve 53 externs, several resulting in internship and job placements
- Provided professional development opportunities including resume/LinkedIn best practice session, mock interviews, financial education, and a Capture-the-Flag event to build confidence in technical skills
- Partnered with Arizona State University and Arizona Technology Council in the ALRISE – Accelerating Latinx Representation in STEM Education



FINANCIAL SERVICES

The Financial Services Workforce Collaborative prioritizes increasing the number of qualified applicants by embedding Securities Industry Essentials (SIE) exam content and required competencies into credit courses within the Maricopa County Community College District.

- Provided financial services training to educators and students in collaboration with ElevateEdAZ



The Health Care Workforce Collaborative focuses on addressing the growing shortage of health care workers.

- Identified and promoted strategies to invest America Rescue Plan Act (ARPA) funds to address nursing shortages
- Aligned high school state standards with industry expectations and needs for health care CTE pathways.



STATE OF THE WORKFORCE REPORT

The state of Arizona's workforce impacts business. With workforce demands in our state and nationwide rapidly evolving, business leaders must stay informed on trends in the labor market. Each year, the Greater Phoenix Chamber Foundation produces an in-depth study on Arizona's workforce. The 2021 State of the Workforce Report highlights trends in Arizona's labor market, local perspectives on talent gap challenges and consumer sentiment on the job market, compensation increases and retraining. Some key findings from this year's report include:

- Arizona's workforce is more diverse today than ever before.
- Maricopa County continues to see exponential growth in high-wage occupations such as health care, business services, transportation, IT, and construction.
- It is a job seeker's market, especially in Arizona where employers continue to establish and expand business operations due to the region's prime talent-pool.
- Post-pandemic, workers value a flexible schedule with 41% of Americans in the labor market reporting they expect to work remotely at least one day a week over the next year.
- The pandemic drastically changed hiring strategies as more companies shifted to a remote workforce. Companies must engage in talent development in order to be competitive in the ecosystem.

AZ CAREERS NOW

The Foundation launched AZ Careers NOW in partnership with Career Connectors in April 2022. AZ Careers NOW is THE go-to place for hiring events. This innovative program allows job seekers to connect with employers in top Arizona industries at both virtual and in-person hiring expos. AZ Careers NOW also provides job seekers with resources to enhance their chances of being hired.



AZ Careers NOW is a program of the Greater Phoenix Chamber Foundation in partnership with Career Connectors. Hiring events are made possible with the support of Maricopa County.

ElevateEdAZ



ElevateEdAZ is preparing Arizona students for college and career through stronger alignment between business, education, and the community. Over the past year, ElevateEdAZ has expanded and is now present in five schools across two districts, impacting over 13,000 students and providing job shadow and internship opportunities to over 100 students. This strategic education initiative is working to:

- Increase the number of students completing high-wage, high-demand career pathways
- Increase attainment of industry-recognized credentials and early postsecondary credit
- Provide more students with opportunities to apply academics through work-based learning experiences
- Empower educators with industry knowledge to align classroom learning with workforce needs


